8- Discussion About Rules for RSC Speed, Disucssion des Règles pour RSC Vitesse

- Annette Hollman- there is a mathematical anomalie, which means skaters who are in a division on their own may be placed into a final that is significantly beyond their abilities. There is a suggestion to scale the qualification times to the faster/ senior times.
- A lot of effort on tabulation- Annette Hollmann is willing to write a program to help with tabulation (Visual Basic, VBA).
- Medals- the overall medals will be awarded based on the equal weighing of sprint and distance races.
- Do a 'reverse' analysis using the 'old' points system.
- In the event of a tie based on the weighing of times.
- Continued education is needed re. rules.
- Tabulation software/ support is required.
