#### **ENTRY FEES**

Each participating country will pay the following entry fees:

400 USD for each country participating at the Senior Championships

100 USD for each senior skater entered for the Track Championships

100 USD for each senior skater entered for the Road Championships

50 USD for each youth skater entered for the Road Championships

50 USD for each youth skater entered for the Track Championships

Are allowed to participate only the countries affiliated to FIRS and in good standing with the FIRS fees.

#### **PARTICIPATION AT THE SENIOR WORLD CHAMPIONSHIPS**

A total of **eight** male and **eight** female skaters may be registered in the Championships for each attending country. No more than **two** male and **two** female skaters can participate in calendar events.

#### **PARTICIPATION AT THE YOUTH WORLD CHAMPIONSHIPS**

A total of **eight** male and **eight** female skaters may be registered in the Championships for each attending country. No more than **two** male and **two** female skaters can participate in calendar events.

#### **DISTANCES**

**The race program will be the same for men and women, Youth and Senior categories**

#### **TRACK**

300 mt time-trial race  
500 mt sprint tournament  
1.000 mt sprint tournament  
10.000 mt points + elimination race  
15.000 mt elimination race  
3.000 mt relays (3 skaters only)

#### **ROAD**

100 mt sprint tournament  
1 lap circuit  
10.000 mt points race  
20.000 mt elimination race  
5.000 mt relays (3 skaters only)

Please, take note that to attend the World **Youth** Championship a **skater shall be aged 15,16,17,18,19 at the December 31, 2015**. Skaters allowed to participate by their age shall although enter either the Senior or the Youth Championship only.

A skater having participated at a World Senior Championship shall not participate to any other World Youth Championship.

#### **ANTI DOPING CONTROL**

The anti doping control will be carried out according to FIRS Medical Regulations and WADA Rules.

#### **CONTROL OF FEMALE SEX**

No female sex certificate is required. Nevertheless, in conformity with IOC guidelines, FIRS is entitled to conduct some tests on specific occasions. This would mean laboratory tests could be done if there is a suspicion.

#### **RULES**

The CIC Official Regulations, **2014 edition** and FIRS Rules will be valid for these Championships.

#### **PASSPORT CONTROL AND PAYMENT OF ENTRY FEES**

It is **scheduled on November 11, 2015 at 10h00am** at venue to be confirmed. Delegates of all attending countries are kindly requested to be present in order to confirm their entry and nationality showing the passports, and for the payment too, if not made, of their entry fees. **In case of payment made in advance, delegates must submit corresponding photocopy.**

#### **CIC MEETING AND PREPARATORY MEETING FOR THE WORLD CHAMPIONSHIPS**

During the preparatory meeting Federations **must confirm skaters participating at each race.**
